On behalf of Appellant John R. Travis, I expect to focus on the following issues during oral argument:

Travis AOB Argument I – Trial court ruling precluding counsel from offering in mitigation of the penalty, at the penalty retrial, a juror and an alternate juror from the first penalty trial, who had become well-acquainted with Appellant after the first penalty trial.

Travis AOB Argument III – Trial court ruling precluding counsel from mentioning the word "mercy" during argument to the jury, and refusal to instruct on mercy (tethered to the circumstances of the crime and the background of the offender) as a factor in mitigation.

Each of these issues will also encompass Travis AOB Argument XII – Facts and legal principles demonstrating prejudice from the various errors at the penalty retrial.
