# MEMORANDUM OF POINTS AND AUTHORITIES IN SUPPORT OF JUDICIAL NOTICE

### I. FACTS SUPPORTING JUDICIAL NOTICE

The Orange County District Attorney charged appellant in count one with human trafficking of a minor in violation of Penal Code section 236.1, subdivision (c). The alleged victim was an adult police officer posing as a minor on the internet. (1 CT 185.) The Orange County District Attorney's theory in appellant's trial was the attempt prong in Penal Code section 236.1, subdivision (c), precludes a charge under the general attempt statute and punishment in accordance with Penal Code section 664. (2 CT 406-412.)

In *People v. Peterson*, Orange County Superior Court No. 15NF1847 (4th Dist. No. G053721; S.Ct. No. S248105), the Orange County District Attorney charged the defendant with an attempted violation of Penal Code section 236.1, subdivision (c). *Peterson* is a case also involving an adult decoy posing as a minor on the internet.

## II. JUDICIAL NOTICE IS APPROPRIATE

Evidence Code section 452, subdivision (d), permits judicial notice of the records of any court in this state. Evidence Code section 459 permits this Court to judicially notice "any matter specified in Section 452."

Appellant refers to the *Peterson* case in Appellant's Answer Brief on the Merits as part of the challenge to respondent's argument. (ABM 33.) Contrary to the argument

made by the same prosecutorial office that prosecuted appellant, the conduct at issue could have been charged under the attempt statutes.

## III. CONCLUSION
