RESPONSES

- Inadequate technology for users / time wasted
- Audibility issues due to insufficient technology by many/all participants
- ► Lack of participants following protocol and orders of Bench Officer
- Participants are muted and continue to speak / time wasted
- Bench Officer in chambers or remotely appearing / inability to communicate with them
- No hard-wired internet access
- Appearances for Attorneys not given on record
- Reporter muted / unable to communicate with Bench Officer

MORE RESPONSES

- Remote attorneys multi-tasking / texting, eating, smoking, talking to kids/others, TV on, dogs, phones ringing,
- Lag time with some technology/ time wasted
- ▶ Lack of courtroom decorum and respect
- WiFi issues / Insufficient broadband / cutting in and out
- Delays / time wasted
- Courthouses not appropriately equipped
- Attorney sanctioned due to inability to connect to remote hearing
- Parties talking over one another due to sound delay

NECESSARY EQUIPMENT FOR OFFICIAL REPORTERS

- Computer and Monitor
- Microphone
- Headphones and Speaker
- Remote program admin rights for reporter
- ► Hardwired secure internet and intranet access
- Courtroom microphones for parties
 - ► Lapel mics or table mics
- Cameras on all participants, including reporter

PROCEEDINGS MUST RUN AS IF EVERYONE IS IN THE COURTROOM

Additional Courtroom Necessities

- Reporter not muted by court staff
- Reporter must have direct communication with Bench Officer
- Remote protocol created and enforced for all participants
- Admonition to each remote participant by Judge before each hearing, including prohibition from recording proceedings

- Remote participant courtroom decorum protocol
 - Same professionalism as in-person
 - No driving
 - Appropriate attire
 - Quiet background atmosphere
- Adequate remote participant technology and connection
 - Or in-person appearance required

Additional Information

- Ask court staff users for input
 - Interpreters
 - ► Encourage feedback from non-English speaking parties
 - Court Reporters
 - Bailiffs
 - ▶ Judicial Assistants/Courtroom Clerks
 - ▶ IT court staff
- No proceedings where testimony is taken
- No juvenile proceedings
 - Minors need to confer with their attorneys in person

WE NEED TO HAVE INPUT TO CREATE APPROPRIATE PROTOCOL



COURT REPORTERS IN CALIFORNIA TRIAL COURTS

OFFICIAL COURT REPORTERS

- ► Courtroom technology experts since the 1980s
- Providing their own equipment saving the courts millions over time
 - Computer Technology state of the art steno machine and laptop
 - Computer Aided Transcription Technology
 - ▶ Realtime for Bench Officer, Attorneys on request
 - CART for hearing impaired litigants/jurors/attorneys
 - Efficient side-bar equipment
 - Immediate readback capability
 - Work after hours with no overtime (GC69954)
 - ▶ 32 years before a transcript rate increase in 2021

Court Budget Effects on Official CSRs

- **>** 2002
 - ► LASC lays off court reporters
- **2012**
 - LASC lays off court reporters (as did many other counties)
 - Takes Officials out of civil courts creating lack of court access for indigents
 - Created freelance reporter market with exorbitant fees for litigants
- **2022**
 - ▶ LASC proposes plan to take officials out of Family Law Departments

HISTORY AND STRATEGY

LEGISLATIVE EFFORTS TO FUND CSRs

- 2009 GC68086.5 civil fee raised
- ▶ 2013 GC68086 \$30 fee kept by County
- ▶ 2018 \$10 million one-time funding for family law reporters
- 2021 transcript rate increase (after 32 years)
- ▶ 2021 \$30 million ongoing funding for civil and family law reporters
 - Courts could not utilize funding for court reporters due to restrictions placed on money by the Judicial Council advocacy
- 2022 \$30 million ongoing funding
 - Language amended to allow courts to compete with private industry, funds to be used for:
 - Recruitment and retention
 - ▶ To be used in all case types

- Advertising
 - Online ads / Social Media / LinkedIn
- CCRA convention presence
- NCRA convention presence
- Journal of Court Reporting ad (print and online)
- ► Hire an Employment Recruiter

- Visiting court reporting schools to talk about benefits

- Attend Career Fairs
- Highlight on-the-job training provided
- Emphasize benefits and no test when advertising
- ► Highlight LACERA retirement reciprocity
- Send employment flyer to all licensed California CSRs
- Cultivate a list of CSRs available to mentor newhires
- Handouts
