The Court has requested that counsel advise the Court and opposing counsel of the issues on which counsel expects to focus at oral argument, calendared for February 6, 2018, at 1:30 p.m., in Sacramento.

As counsel for appellant, I intend to focus on two issues:

Argument I in the AOB: By refusing to grant appellant's motion to continue the trial to allow witness Joe Galindo to testify, the trial court unreasonably restricted appellant's ability to present his defense in violation of appellant's Sixth Amendment right to the effective assistance of counsel, and to present a defense, and precluded a fair and reasonable trial required by due process and the Eighth Amendment.

Argument IV in the AOB: Appellant established a prima facie claim of racial discrimination during voir dire of the guilt phase jury, entitling him to a reversal.
