Argument V: *Purifoy v. State* (Fla. 2017) 225 So.3d 867, 869-871 [a man who walked into an emergency room with a gunshot wound retained a possessory interest in his clothing which had been removed by hospital personnel and placed in a bag at the foot of the stretcher; therefore, the seizure of the clothing by the police without a warrant violated his constitutionally protected possessory right].

Argument IX(A): *State v. Blackwell* (S.C. 2017) 801 S.E.2d 713, 725-728 and n.19 ["the majority of jurisdictions in the United States have determined that a criminal defendant's rights ... may supersede a witness's rights or statutory privilege" citing cases from 18 jurisdictions which allow this and 5 jurisdictions which do not, including *People v. Hammon* (1997) 15 Cal.4th 1117.]

Argument XIV: The Bench Notes to CALCRIM No. 202 state that "No statute or rule of court requires any particular disposition" of the notes taken by jurors during trial.
