The mediation process allows parties to freely engage in an exchange of facts and reasoning, giving participants perspective and understanding of the other side's case, perspective and understanding that often leads to dispute resolution.

Mr. Van Vleck has mediated numerous business, complex real estate, and construction cases. Some examples include:

- secured lender claim against borrower and other lenders regarding title and priority of lien rights.
- Multiple-subtractor lien claims against real estate owner after general contractor absconding with construction funds.

- Commercial-property rights and responsibilities under conflicting commercial leases and recorded easements on historic property.
- Indemnitors' liabilities under bond company claims upon failed construction.
- Residential real estate fraud claims in sale of real property.
- Commercial real estate leasing dispute resulting from Covid-19's mandatory shutdown.
- Commercial landlord tenant indemnity claims.
- Multi-party real property partition actions, both commercial and residential.
- General commercial litigation matters including rescission, fraud, breach of fiduciary duty, and controlling shareholder liability.

Mr. Van Vleck is the Chairman of the American Bar Association Section of Real Property Litigation subcommittee on commercial real estate litigation. He has been recognized year over year as a *Northern California Super Lawyer*. He writes for several publications for the American Bar Association.
