# 1.0 BACKGROUND INFORMATION

# 5.0 SUBMISSIONS OF PROPOSALS

- 5.1 Proposals should provide straightforward, concise information that satisfies the requirements of Section 7 ("Proposal Contents"). Expensive bindings, color displays, and the like are not necessary or desired. Emphasis should be placed on conformity to the RFP's instructions and requirements, and completeness and clarity of content.
- 5.2 Proposals must be delivered by one of the options below
  - a. Mail: The Proposer must submit **one** (1) **original and one** (1) **copy of** the technical proposal and the cost proposal, as well as the additional attachments. The original must be signed by an authorized representative of the Proposer. The Bidder must write the RFP title and number on the outside of the sealed envelope. Proposals should

be sent by registered mail, certified mail, overnight courier, or by hand delivery and must be delivered by the date and time listed on the coversheet of this RFP to:

- b. E-mail: Proposals may be submitted by E-mail to:

  <u>ConferenceRFPs@jud.ca.gov</u> and must be delivered by the date and time listed on the coversheet of this RFP. Bidders must write the RFP title (Domestic Violence Institute) and number (CRS PD 321) in the subject line of the E-mail. The only acceptable proof of delivery for submittals made by E-mail will be the automated receipt (with a date and time receipt) generated by JCC upon the successful receipt of the bidders' proposal.
- 5.3 Late proposals will <u>not</u> be accepted regardless of the method sent. Proposer assumes all risk of late delivery by e-mail or any other method. Proposals received after the deadline will be rejected without review.
- 5.4 Incomplete submittals may be rejected without review

# 6.0 PROPOSAL & COST CONTENTS

- 6.1 <u>Technical & Cost Proposal (Attachment 5)</u>. The following information must be included in the technical & cost proposal. A proposal lacking any of the following information may be deemed non-responsive.
- A. Legal name and address of firm (Proposer), the Contact's name, title, telephone numbers and E-mail address, federal tax identification number, web site, hotel check-in/out time, and guest room reservation cancellation policy. Note that if Proposer is a sole proprietor using his or her social security number, the social security number will be required before finalizing a contract
- b. Propose room block date.
- c. Propose sleeping room unit rate(s).
- d. Answer ADA compliance question.
- e. Propose the cut-off date for reservations.
- f. Propose the sleeping room rate(s) for tax and/or surcharges.

- g. Propose parking passes, complimentary passes and normal parking rate(s), inclusive of any service charges, gratuity, and/or sales tax.
- h. Propose Internet fees for meeting space and individual guest rooms.
- i. Acceptance of additional program needs and concessions.
- j. Provide the signature of the proposer.

**NOTE:** It is unlawful for any person engaged in business within this state to sell or use any article or product as a "loss leader" as defined in Section 17030 of the Business and Professions Code.

- 6.2. Acceptance of the Terms and Conditions.
  - 8. On Attachment 3, the Proposer must either indicate acceptance of the Terms and Conditions or clearly identify exceptions to the Terms and Conditions in the Standard Agreement (Attachment 2).
  - **8.** If exceptions are identified, the Proposer must also submit a red-lined version of the Terms and Conditions that clearly tracks proposed changes, and a written explanation or rationale for each exception and/or proposed change.
  - 8. Note: A material exception to a Minimum Term will render a proposal non-responsive.
- 6.3. Certifications, Attachments, and other requirements.
  - **8.** Proposer must include the following certification in its proposal:

Using Attachment 6, Proposer has no interest that would constitute a conflict of interest under California Public Contract Code sections 10365.5, 10410 or 10411; Government Code sections 1090 et seq. or 87100 et seq.; or rule 10.103 or rule 10.104 of the California Rules of Court, which restrict employees and former employees from contracting with judicial branch entities.

- 8. If Proposer has had business activities or other operations outside of the United States within the previous three years, Proposer must complete the Darfur Contracting Act Certification attached as Attachment 4 and submit the completed certification with its proposal.
- **8.** If Proposer is a corporation, proof that Proposer is in good standing and qualified to conduct business in California.

# 6.4 **Submission of Proposals**

- a. The Proposer should include the following attachments:
  - Attachment 2 Judicial Council of California Standard Terms and Conditions only if there are exceptions/modifications as indicated on Attachment 3.
  - Attachment 3 Proposer's Acceptance of Terms and Conditions
  - Attachment 4 Darfur Contracting Act Certification
  - Attachment 5 Submission form for Technical & Cost Proposal
  - Attachment 6 Conflict of Interest Certification Form

## 7.0 OFFER PERIOD

A Proposer's proposal is an irrevocable offer for ninety (90) days following the proposal due date. In the event a final contract has not been awarded within this ninety (90) day period, the Judicial Council of California reserves the right to negotiate extensions to this period.

## 8.0 INTERVIEWS

The Judicial Council of California may conduct interviews with Proposers to clarify aspects set forth in their proposals. If conducted, interviews will likely be conducted by phone or during site visits. The Judicial Council of California will not reimburse Proposers for any costs incurred pertaining to an interview, including travel expenses. The Judicial Council of California will notify eligible Proposers regarding interview arrangements.

# 9.0 RIGHTS

The Judicial Council of California reserves the right to reject any and all proposals, in whole or in part, as well as the right to issue similar RFPs in the future. This RFP is in no way an agreement, obligation, or contract and in no way is the Judicial Council of California or the State of California responsible for the cost of preparing a proposal. One copy of each proposal will be retained by the Judicial Council of California for official files and will become a public record.

### 10.0 CONFIDENTIAL OR PROPRIETARY INFORMATION

California judicial branch entities are subject to rule 10.500 of the California Rule of Court (see <a href="www.courtinfo.ca.gov/cms/rules/index.cfm?title=ten&linkid=rule10\_500">www.courtinfo.ca.gov/cms/rules/index.cfm?title=ten&linkid=rule10\_500</a>), which governs public access to judicial administrative records.

If information submitted in a proposal contains material noted or marked as confidential and/or proprietary that, in the Judicial Council of California's sole opinion, meets the disclosure exemption requirements of Rule 10.500, then that information will not be disclosed upon a request for access to such records. If the Judicial Council of California finds or reasonably believes that the material so marked is **not** exempt from disclosure, the Judicial Council of California will disclose the information regardless of the marking or notation seeking confidential treatment.

# 12.0 PROTESTS
