What is a family law facilitator?

A family law facilitator is an attorney licensed to practice law in California who has been appointed by the superior court of a California county. Each superior court is required to maintain an Office of the Family Law Facilitator to assist self-represented persons, regardless of your income, with issues of child support, spousal support, and health insurance.

What does a family law facilitator do?

The family law facilitator can help you with child support, spousal support, and health insurance issues. He or she can:

- · Give you educational materials.
- Give you court forms.
- · Assist you with court forms.
- Calculate the guideline child support.
- Refer you to the local child support agency (LCSA), family court services, and other community agencies.

The family law facilitator may have additional duties, depending upon funding and other resources.

Will the family law facilitator assist me with an out-of-county case?

A family law facilitator in any county within California can provide you with basic forms, information, and procedures related to child support issues. However, the family law facilitator in the county where the action is filed is best equipped to assist you with questions on local procedures and case information.

What information do I need when I visit or contact the family law facilitator?

- Bring all relevant court documents.
- Bring your paycheck stubs from the last 2 months.
- Bring proof of other income (such as rental income, tips, social security, unemployment, workers' compensation, disability, or any other money received).
- Bring a copy of your most recent federal and state tax returns.

If you need copies of your court file, go to the court clerk's office where your case is filed to obtain copies. There is a fee for copies unless you qualify for a fee waiver. Ask the court clerk for the fee waiver form.

Can a family law facilitator represent me?

No. The family law facilitator cannot represent you or the other party. The family law facilitator is a neutral person. Both you and the other party in your case may receive assistance from the same family law facilitator.

There is no attorney-client privilege between the family law facilitator and any person he or she assists. Matters discussed with the family law facilitator are not confidential. The family law facilitator is not responsible for the outcome of your case.

For specific or strategic legal advice in your case, contact a private attorney or the bar association's lawver referral service to ask for a short consultation at a low cost.

Will foreign-language interpreters be available to translate for me?

Some family law facilitator offices may have bilingual staff who can assist when available, but if you need an interpreter it is best to bring your own.
