Draft Model Complaint Form and Procedures [ACTION ITEM]

The Budget and LAP Monitoring Subcommittee will discuss the development of a model complaint form and related procedures for the trial courts. The complaint materials include recommended procedures; a model complaint form along with accompanying instructions for court users to complete the form; best practices to assist the courts; and a web-based complaint form for Judicial Council services only to be hosted on the language access webpage. The subcommittee recommends that the Task Force (1) approve the model complaint form and procedures for distribution to all trial courts and posting on the *Language Access Toolkit*, and (2) proceed with development of a related Rule of Court to make clear that all courts must develop a complaint form and process.

Draft Court Web Content Guidance Materials [INFORMATIONAL ITEM ONLY]

The Budget and LAP Monitoring Subcommittee will discuss the development of web guidance materials on language access that will help courts update their websites for consistency and uniformity throughout the state. The subcommittee recommends that the materials be distributed to all trial courts and posted on the *Language Access Toolkit*.
