## **Hon. Mariano-Florentino Cuéllar, Chair**

### **Associate Justice of the California Supreme Court**

Justice Mariano-Florentino Cuéllar began serving on the California Supreme Court in January 2015. He was nominated by Governor Jerry Brown, confirmed unanimously by the Commission on Judicial Appointments, and retained by the voters for a full term in November 2014. A member of the Stanford University faculty from 2001 to 2015, Justice Cuéllar was the Stanley Morrison Professor of Law and Professor (by courtesy) of Political Science. Justice Cuéllar also served in the federal executive branch. While on leave from Stanford, in 2009 and 2010, he worked at the White House as Special Assistant to the President for Justice and Regulatory Policy. He was a presidential appointee, between 2010 and 2015, to the governing council of the U.S. Administrative Conference, an agency designed to improve fairness and efficiency in federal administrative procedures. He co-chaired the U.S. Department of Education's National Equity and Excellence Commission from 2011 to 2013. Before that, in 2008 and early 2009, he co-chaired the presidential transition team on immigration, borders, and refugees. A naturalized U.S. citizen born in northern Mexico, Justice Cuéllar graduated from Calexico High School in California's Imperial Valley. He holds a Juris Doctorate from Yale Law School, a Ph.D. in Political Science from Stanford, and a Bachelors of Arts from Harvard University magna cum laude.

## **Hon. Manuel J. Covarrubias, Vice Chair**

### **Judge of the Superior Court of California, County of Ventura**

Judge Manuel Covarrubias was appointed to the Ventura County Superior Court in 2002 to a Family Law assignment and continues to serve in Family Law. He also served as a member of the Access and Fairness Advisory Committee and as co-chair to Access and Fairness' Race and Ethnic Subcommittee. In 2011, Judge Covarrubias was appointed to the Court Interpreters Advisory Panel, and is currently an active member. He was the co-chair of the Joint Working Group for California's Language Access Plan. Judge Covarrubias often volunteers to participate in the Court Interpreters Ethics Workshop for new interpreters, serving as a panel member, offering new interpreters advice, answering questions and relating his experience working with court interpreters. Prior to being named to the bench, Judge Covarrubias was the Superior Court Commissioner in Ventura County, a position he held from 1993 to 2002. Judge Covarrubias is fluent in Spanish and has served on the boards of a number of Hispanic community and professional organizations. Judge Covarrubias holds a Juris Doctorate from Loyola School of Law.

## **Ms. Naomi Adelson**

### **Court Employee Interpreter (Spanish), Superior Court of California, County of Alameda**

Ms. Naomi Adelson is a Spanish language court employee interpreter at Alameda County Superior Court. She is one of the founders of Asociacion Mayab, and is a trainer for Mayan speakers as legal interpreters. ### **Hon. Steven K. Austin**

#### **Judge of the Superior Court of California, County of Contra Costa**

Judge Steven Austin has served as a trial court judge at the Contra Costa County Superior Court in California since 1998 (Presiding judge 2015-2016). He has served as a branch court supervising judge, supervising judge of the civil departments and as a member of the court's executive committee. Judge Austin was a member of the Judicial Council's Access and Fairness Advisory Committee from 1999 to 2011, and served on the executive committee for several of those years. He is also a past Chair of the Center for Judiciary Education and Research (CJER) Fairness Education Committee. From 2005 to 2014, he was one of two judicial members of the California Commission on Access to Justice and served as Chair from 2007 to 2010. From 2010 to 2016, he served as the Chair of the council's Court Interpreters Advisory Panel (CIAP). In 2013, he also served as Chair of the council's Ad Hoc Group for Court Interpreter Issues. From 2013–15, he was a member of the Joint Working Group for California's Language Access Plan, the advisory body that developed the *Strategic Plan for Language Access in the California Courts*. From 2015 to present, he serves as the Chair of LAP Implementation Task Force's Budget and LAP Monitoring Subcommittee, and is a member of the Language Access Plan Implementation Task Force. He frequently serves as faculty for judicial education programs, including several satellite broadcasts for judges and court staff. Judge Austin holds a Juris Doctorate from University of California, Hastings College of Law, and a Bachelor's degree in communication studies from University of California, Los Angeles.

### **Mr. Kevin Baker**

#### **Legislative Director, American Civil Liberties Union (ACLU), Sacramento**

Mr. Kevin Baker is the Legislative Director for the American Civil Liberties Union of California (ACLU). As Legislative Director at the ACLU, he provides direct legislative advocacy for a statewide nonprofit organization focused on civil rights and freedoms with concentration on equal protection and non-discrimination, due process, racial justice, employment rights, free speech, access to justice, immigrants' rights, language access and privacy issues. Prior to his position at the ACLU, he was the Deputy Chief Counsel for the Committee on the Judiciary for the California Assembly where he worked extensively on court interpreter and equal access issues, including as the primary drafter of AB 1657. He holds a Juris Doctorate from New England School of Law, Boston, and a Bachelor's degree in Public Policy from Michigan State University.

### **Ms. Angie Birchfield**

#### **Independent Contractor Court Interpreter (Spanish)**

Ms. Angie Birchfield is a Spanish independent contractor court interpreter. She became certified in April 1999 and is the owner of ABinterpreting Services. Ms. Birchfield is a current member of the Video Remote Interpreting (VRI) Pilot Project Workstream, an informal body of judges,

court staff, and court interpreters, which is currently advising Judicial Council staff and three participating courts on implementation of the VRI pilot project. She is also the Chair of the Interpreters Guild of America (IGA). She holds a Bachelor of Science degree from California State Polytechnic University.

### **Hon. Terence L. Bruiniers**

#### **Associate Justice of the Court of Appeal, First Appellate District, Division Five**

Justice Terence Bruiniers was appointed to the First District Court of Appeal, Division Five in June 2009. Prior to that, he served on the Contra Costa Superior Court for over ten years. He has served in the Criminal, Family Law, and Civil Divisions, as the assigned judge in the Complex Litigation Department, and as the Presiding Judge of the court from 2007 through 2008. Before his appointment to the bench, he was a principal in the San Francisco firm of Farrand, Cooper & Bruiniers. In his practice, he handled business and commercial litigation, as well as maintaining a business transactional practice, representing national and international clients in technology-related matters. Judge Bruiniers has served on the Court Technology Advisory Committee to the Judicial Council since 1999 and currently serves as Chair of that committee. He is a 1969 graduate of the University of California, Berkeley, and a 1973 graduate of Boalt Hall (Order of the Coif).

### **Ms. Tracy Clark, MA, SC: L**

#### **Manager, Court Interpreting Services, Superior Court of California, County of Ventura**

Ms. Tracy Clark is a certified American Sign Language (ASL) court interpreter who worked for over 25 years as an independent contractor before becoming a staff interpreter in 2006. In 2011, she became the Manager of Interpreting Services for the Ventura County Superior Court, overseeing interpreting services of all languages. Ms. Clark has a Master of Arts in Linguistics from California State University, Northridge, where she also taught courses in interpretation and linguistics. She has served on the Court Interpreters Advisory Panel for over six years, chairing the ASL Subcommittee that developed the *Recommended Guidelines for Video Remote Interpreting (VRI) for ASL-Interpreted Events*.

### **Hon. Jonathan B. Conklin**

#### **Presiding Judge of the Superior Court of California, County of Fresno**

Judge Jonathan Conklin has served as a trial judge at Fresno County Superior Court since 2006 and is currently the presiding judge for the court. He also works with the Executive Committee to set policies for the court related to judicial functions. Judge Conklin has also handled a misdemeanor trial calendar and civil calendar, which included limited civil matters, unlawful detainers, small claims and temporary injunctions. Prior to his appointment to Fresno County Superior Court, he was the deputy chief for the Fresno Branch Office of the U.S. Department of Justice, Office of the U.S. Attorney, Eastern District, from 2003 to 2005. From 2001 to 2003, he was a senior litigation counsel, and from 1990 to 2001, Assistant U.S. Attorney, both for the U.S. Attorney's Office. Judge Conklin has been teaching as an adjunct professor at San Joaquin College of the Law in Fresno since 1993. He is a member of the council's Trial Court Budget

### **Hon. Michelle Williams Court**

#### **Judge of the Superior Court of California, County of Los Angeles**

Judge Michelle Williams Court currently serves on the council's Civil Working Group, Commission on the Future of California's Court System. She is a former member of the council's Probate Conservatorship Task Force. Judge Court was appointed by Governor Jerry Brown in December 2011, and was elected in 2014 for a term that expires in January of 2021. Previously, since 2002, Judge Court worked for Bet Tzedek Legal Services, including serving as vice president and general counsel. Bet Tzedek is recognized as one of the premier legal service agencies in the country and assists over 15,000 individuals a year in the Los Angeles area with legal problems such as caregiver issues, consumer fraud, employee rights, and foreclosure matters. Previously, she was a senior associate for Milberg LLP from 2000 to 2002. She served as a community builder fellow and civil rights specialist for the U.S. Department of Housing and Urban Development from 1999 to 2000. She was a litigation associate for Litt and Marquez from 1995 to 1999. From 1994 to 1995, Judge Court was a project attorney for the American Civil Liberties Union of Southern California. She was an associate for Gilbert Kelly Crowley and Jennett from 1993 to 1994. Judge Court earned a Juris Doctorate degree from Loyola Law School and a Bachelor of Arts degree from Pomona College.

### **Hon. Janet Gaard**

#### **Assistant Presiding Judge of the Superior Court of California, County of Yolo**

Judge Janet Gaard is the Assistant Presiding Judge for Yolo County Superior Court. Since her appointment to the court in 2008, she has presided over criminal, civil, and probate calendars. She currently presides over a family law calendar, drug court, and mental health court. Judge Gaard is a member of the Governing Committee of the Center for Judiciary Education and Research, which develops and delivers education to members of California's judicial branch, teaches at the California Judicial College for new judges, and is a member of the Criminal Law Advisory Committee to the California Judicial Council. Previously, she had a long career with the California Attorney General's Office, serving as Chief Assistant Attorney General for the Division of Public Rights, Special Assistant Attorney General and Director of Legislative Affairs, and Deputy Attorney General in the Division of Criminal Law. Previously, she served on both the Elkins Implementation Task Force and the Elkins Family Law Task force where she worked with legal advocates, court administrators and judges to develop policy recommendations for making the family law process more efficient and user friendly. She was a panelist at the Sacramento Language Access Plan public hearing on developing the Language Access Plan (LAP), and assisted in drafting comments on the LAP. Ms. Garcia holds a Juris Doctorate from University of La Verne College of Law.

### **Hon. Dennis W. Hayashi**

Judge Dennis Hayashi has devoted his entire life to serving the public and working to preserve individual civil liberties. He currently serves as a judge at the Alameda County Superior Court, and is a member of the council's Advisory Committee on Providing Access and Fairness. Under President Clinton, Judge Hayashi was the Director of the Office for Civil Rights in the U.S. Department of Health and Human Services. As one of the top public officials in the Clinton Administration, Judge Hayashi was responsible for ensuring that civil rights laws were enforced including the Age Discrimination Act, Americans with Disabilities Act and Title VI of the Civil Rights Act. Previously, Judge Hayashi served as the Director of the California Department of Fair Employment and Housing. The Department protects the rights of seniors, women, the disabled and minorities who face discrimination on the job, in housing, or public accommodations. Prior to his elevation to the Court of Appeal, he served on the Fresno County Superior Court for 10 years in various assignments, including outlying courts in Fowler and Kingsburg, the Juvenile Delinquency Court, the felony home court, and a general trials assignment in the Criminal Courts Building downtown. Justice Peña received his Bachelor's degree in Political Science from California State University, Fresno. Thereafter he studied at University of California, Los Angeles School of Law, served as a Student Bar Representative, and received his Juris Doctorate degree in 1980.

### **Hon. Jonathan K. Renner**

#### **Associate Justice of the Court of Appeal, Third District**

Justice Jonathan Renner was nominated to the Third Appellate District of the California Court of Appeal by Governor Edmund G. Brown, Jr. Following his unanimous confirmation by the Commission on Judicial Appointments, and election by California voters, Justice Renner joined the court in January of 2015. In the four years prior to joining the court, he served as the Legal Affairs Secretary to Governor Brown. Justice Renner provided advice and counsel to the Governor and top administration officials, and oversaw the defense of significant litigation against the Governor and the administration. Before working in the Governor's Office, Justice Renner was the statewide head of the Government Law Section at the California Department of Justice. At the Department of Justice, his legal practice focused on the operation of state government and the authority of government officials. Justice Renner holds a Juris Doctorate from the University of the Pacific, McGeorge School of Law and a Bachelor of Arts degree from the University of California at Davis.

### **Mr. Michael M. Roddy**

#### **Court Executive Officer, Superior Court of California, County of San Diego**

Mr. Michael Roddy is the Court Executive Officer at San Diego County Superior Court. He has more than 30 years of court administration experience, both in the trial courts and in state court administration. ##### **Court Executive Officer, Superior Court of California, County of Orange**

Mr. David Yamasaki is currently the Court Executive Officer of Orange County Superior Court. He was previously the Court Executive Officer of Santa Clara Superior Court for eight years and has over 31 years of experience working in the Judicial Branch. Mr. Yamasaki's past experience includes working for the Superior Court in San Diego County and Los Angeles Municipal Court, where he was actively involved with case calendar management, development of and enhancement of automated case management system, and court fiscal and personnel management. Currently at the Orange County Superior Court, he oversees an operation of over 1500+ employees operating from nine separate court facilities. ##### **Associate Justice of the Court of Appeal, Second Appellate District, Division Seven**

Justice Laurie Zelon has served as an associate justice of the California Court of Appeal since 2003. During the twenty-three years that preceded her appointment to the Los Angeles Superior Court in 2000, she had an active litigation practice, involving scientific and technical issues, fiduciary obligations, and other complex commercial disputes. Justice Zelon has been a long-time member and served as Chair of the California Commission on Access to Justice. She is an active member of several statewide judicial committees addressing administration of justice issues. She is co-chair of the Judicial Council's Advisory Committee on Providing Access and Fairness. She is a past President of the Los Angeles County Bar Association. She is a past member of its Board of Trustees, and past Chair of its Federal Courts Committee, its Judiciary Committee, its Access to Justice Committee, and its subsection on Real Estate Litigation. Justice Zelon holds a Juris Doctorate from Harvard Law School and has a Bachelor's degree from Cornell University.
