
1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above ("Agreement"). As set forth in the Agreement, the term "Contractor" refers to **Stria, LLC** and the term "Judicial Council", "Establishing JBE" or "State" refers to the **Judicial Council of California**.
2. This Amendment becomes effective on **September 1, 2022**.
3. **Bitwise Technology Consulting, LLC. A California limited liability company ("Bitwise")** is in the process of acquiring **Stria, LLC**, through a change of ownership. Therefore, Stria, LLC (Contractor) (a) assigns the Agreement, and all obligations and benefits therein to **Bitwise**, (b) covenants and agrees that the Agreement shall continue in full force and effect, subject to all of its terms and conditions, (c) waives any notice requirements set forth in the Agreement, and (d) waives any termination rights which may arise as a result of assigning the Agreement to Bitwise.

This assignment and assumption agreement ("Assignment") is made as of September 1, 2022 (the "Assignment Date") among Stria ("Contractor"), and the Judicial Council of California ("Judicial Council") and Bitwise Technology Consulting, LLC. ("Bitwise") regarding Master Agreement Number MA-2020-05 (the "Agreement").
  - A. **Assignment and Assumption.** Bitwise is in a position to fully perform all obligations that may exist under the Agreement. Contractor hereby fully and forever assigns all of its rights, interests, duties and obligations in, to and under the Agreement to Bitwise, for good and valuable consideration. Bitwise hereby accepts Contractor's assignment and assumes and agrees to perform all the duties and obligations of Contractor arising under the Agreement from and after the Assignment Date. Bitwise ratifies all previous actions taken by the Contractor with respect to the Agreement, with the same force and effect as if the action had been taken by Stria. With respect to all rights and obligations arising from and after the Assignment Date, the term "Contractor" in the Agreement, will continue to refer to Stria, LLC.
  - B. **Consent.** Judicial Council consents to the assignment and assumption of the Agreement from Contractor to Bitwise pursuant to this Agreement and acknowledges that the Agreement will remain in full force and effect in accordance with its terms, as modified in this Assignment. This Assignment will apply to, bind, and inure to the benefit of the parties and their respective heirs, legal representatives, successors, and assigns, from and after the Assignment Date. Pursuant to Sections 5 and 16 of Exhibit 3 to the Agreement, this assignment will not be applicable or valid on Participating Entities without the prior written approval of the affected JBE that executed its respective Participating Addendum to the Agreement.
  - C. The parties agree that this Assignment represents the parties' entire understanding regarding its subject matter.
  - D. This Amendment may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute as a single contract.

5. The parties agree that except as provided in this Amendment, all terms and conditions of the original Master Agreement shall remain in full force and effect.
