Note: The end of the first quarter of 2020 (the first period for which the reporting of these data was mandatory for courts) and the usual reporting period for data reflecting activity during that quarter (one month following the end of the quarter) corresponded with the initial weeks of the COVID-19 shelter-in-place (SIP) order in California. This, in addition to subsequent orders and the closure of many court buildings, meant superior court staff across much of the state may not have the opportunity to access the data systems or set up the queries required to report these data to the Judicial Council. The data for these petitions and programs reported therefore should not be interpreted as a comprehensive count of statewide totals but rather a subset of them. The data that has been reported, moreover, may not have been as thoroughly vetted as it would have been in usual circumstances and as such may be subject to future changes.

¹ Subtotal of cases with at least one felony charge were not included in survey originally and so are not available for this period.

² Due to COVID-19 pandemic, these counties were not able to provide these items in time for inclusion in this report.
