Section 4.B.1. of Attachment A lists various reviews and services at various Program, Schematic and Design Development submittal levels. However, the Contract Schedule in Exhibit A shows the Schematic Phase as N.A. and that the Design Development phase is scheduled to be complete in Sept/Oct 2011 which is about the same time that the Schedule of Events shows the Intent to Award posting.	The CM@R would begin services at the beginning of the Working Drawing phase; no services for earlier phases would be required.
2	General	Have any previous renovations taken place in the building? If so, what was the nature of the renovation and when did it occur?	There have been multiple renovations done by the County over the 100 years of the building's life. It is believed most if not all of the work has been interior non-bearing construction, much of which will be removed by our renovation.
3	General	Do you intend for the Construction Manager at Risk contract to include HAZMAT abatement?	Yes.
