DISCUSSION AND ACTION ITEMS

ltem 1

Proposal for Judicial Council-Sponsored Legislation

Allocation of Vacant Judgeships

Allows the allocation of vacant judgeships from courts with less judicial workload needs to courts with greater judicial workload needs, as proposed by the Commission on the Future of California's Court System.

Action: Recommend for Judicial Council-sponsorship to provide that up to five vacant judgeships may be allocated from courts with more authorized judicial positions than their assessed need to courts with fewer authorized positions than their assessed need. The allocation of vacant judgeships shall be in accordance with a methodology approved by the council, after solicitation of comments. Support the Governor's Budget Proposal, and continue discussions with legislative and executive branches about the judicial branch's need for additional judgeships. The Judicial Council will work vigorously with the executive and legislative branches to come up with more permanent solutions.
