**Judicial Council-Sponsored Legislation (Court Facilities): Disposition of Mental Health Courthouse (Action Required)**

The Los Angeles County Mental Health Courthouse facility has been permanently closed and is unsuitable to the needs of the judicial branch. The local court supports disposition of this facility. To eliminate the council's continuing liability and expense in holding this facility and to realize its value in a fair-market-value sales transaction, the Policy Coordination and Liaison Committee and Facilities Policies Working Group recommend that the Judicial Council approve the sale of this facility as nonsurplus property and direct council staff to take all actions necessary to dispose of it.
