1. The Supreme Court and The Court of Appeal, First Appellate Court

The Supreme Court and the **1st District** are located in San Francisco.

The **1st District's** jurisdiction is over the following counties: Alameda, Contra Costa, Del Norte, Humboldt, Lake, Marin, Mendocino, Napa, San Francisco, San Mateo, Solano, and Sonoma. It is divided into five non-geographical divisions with four justices each.

The **2nd District** main courthouse is in Los Angeles. The secondary courthouse, hosting Division Six, is in Ventura. Division Six handles appeals from San Luis Obispo, Santa Barbara, and Ventura Counties, while Divisions One through Five, Seven, and Eight handle appeals from Los Angeles County. Each division has four justices.

3. Third Appellate District

The **3rd District** is located in Sacramento. Its jurisdiction is over the following counties: Alpine, Amador, Butte, Calaveras, Colusa, El Dorado, Glenn, Lassen, Modoc, Mono, Nevada, Placer, Plumas, Sacramento, San Joaquin, Shasta, Sierra, Siskiyou, Sutter, Tehama, Trinity, Yolo, and Yuba. It has 11 justices and is not divided into divisions.

4. **Fourth District Court of Appeal**

- **Division 1** is located in San Diego and has jurisdiction over matters from Imperial and San Diego Counties.

- **Division 2** is located in Riverside and has jurisdiction over matters from Inyo, Riverside, and San Bernardino Counties.

Fourth District Div 3

- **Division 3** is located in Santa Ana and has jurisdiction over matters from Orange County.

5. **Fifth District Court of Appeal**

The **5th District** is located in Fresno. Its jurisdiction is over the following counties: Fresno, Kern, Kings, Madera, Mariposa, Merced, Stanislaus, Tulare and Tuolumne. The Court has 10 justices and is not divided into divisions.

6. **Sixth District Court of Appeal**

The **Sixth District** is located in San Jose and has jurisdiction over the following counties: Monterey, San Benito, Santa Clara, and Santa Cruz. The court has seven authorized judicial positions, consisting of a presiding justice and six associate justices. The court does not have divisions.
