1	N/A	Please provide contact names, numbers, and emails for any and all general contractors bidding this work so that our price for elevator modernization can be correctly incorporated into their bids.	Per Public Contract Code, we are unable to release that information.  See September 25, 2017 Update to the Solicitation Webpage for a list of the Teleconference Participants
2	N/A	Would it be considered to instead have all elevator companies bid to the JCC for their elevator work then the GC's bid their Work by Others price to the JCC separately? The JCC could then choose their elevator company and their GC then the GC would incorporate the elevator price into the GC's price at the predetermined mark-up. This will allow the basis of award for the elevator work to be determined by the JCC.	No, not for this solicitation. Please follow the RFP as failure to do so could render proposals non-responsive.
3	RFP Section 5.0 – 6.0	Will the GC be submitting the proposal package and statement of qualifications package for the project which includes the elevator scope of work pricing?	GCs should submit the Proposal Packages, which includes both the Statement of Qualifications Package and Cost Proposal Package.
4	Project Manual Part 1.04	Related Building work. Please confirm that this work is to be priced out by the GCs bidding the job?	Related work is to be provided as specified. Related building work is responsibility of other trades as specified.
5	Project Manual Part 2.01 B	Motion Control Engineering or "approved equal." What constitutes an approved equal controller? Also what is the process to obtain "approved equal" status for the control system?	Approved equal would be TKE, Otis, KONE, MEUS, SECO controllers are an as equal.
6	Project Manual Part 2.04 B	Due to elevators 1-3 and 5-6 sharing the same lobby it would most prudent and beneficial to utilize a destination dispatching (DD) system whereby all elevators are dispatched based on the specific destination entered by each guest. This will simplify the overall interfacing with the elevators and will provide a greater degree of security for the facility. Are bidders able to provide a value engineering alternate for a DD system?	The DD System was discussed with the facility and it was determined the general use would not afford adaptability to this system.
7	Project Manual Part 2.05 A	Interface with building security system – what is the existing security system in place, who is the manufacturer and will it be necessary to tie the elevators into the existing system? Or are we to provide provisions as stated in B. for future activation? For any tie-in to the existing system, are bidders to assume that this will be a GC-carried cost?	Tie into existing systems is required.

Vandal resistant buttons do not meet this requirement of full illumination. Are we to provide California compliant push button similar to the MAD Atoll, Innovation Industries PB55, PB69, or PB70 to meet this requirement? Please verify that bidders are to include the same push buttons for the car and hall side?	Fully illuminated vandal resistant pushbuttons are available.  CA Compliant buttons are required. If the proposed meet CA requirements then they are acceptable. The same manufacturer is required for the pushbuttons. The illumination design can vary to meet CA code requirements.
13	N/A	Building Generator Power – are any of the existing elevators on building generator power? What specific elevators are on generator power? Will a generator transfer switch with pre-signal connection be required? If so will that cost be carried by the GC?	All of the elevators at ECRC are connected to the emergency power system and generators.
14	Project Manual Part 1.13 A.5	Ride Quality – Please proved the existing ride quality measurements for all elevators in this project.	Existing measurements are not called for in the specs. The section is a requirement for the modernization
15	Project Manual Part 2.08 H	Headers provide new – existing equipment is GAL, why does it appear that bidders are being requested to replace the hall door headers when the replace headers will be identical to the existing headers?	All new equipment is required so to provide the courthouse with as new operation and reliability.
16	N/A	Will mechanics require tools to be checked each morning?	Yes, tool checks are required for all vendors
17	N/A	Can we identify lay down area for tools, gang boxes, etc.	Yes, SECo can identify a lay down area for approval.
