Resources for High-Quality Legal Representation for Children and Parents in Child Welfare Proceedings

This document summarizes a small sample of the key resources available to ensure high-quality legal representation for children and parents in child welfare proceedings.

Family Justice Initiative (FJI)

Led by the American Bar Association Center on Children and the Law, the Children's Law Center of California, the Center for Family Representation, and Casey Family Programs the FJI brings together a national collaborative of parents' attorneys, children's attorneys, researchers, educators, and advocates working together to meet the initiative's goals. The mission of FJI is to strengthen families through the provision of high-quality legal representation for children and parents involved in the child welfare system.

Cornerstone Advocacy Model

"Cornerstone Advocacy" is a promising approach to supporting family reunification that focuses on intensive advocacy during the first 60 days of a child welfare case to focus on placement, services, family conferences, and visitation. The model was developed by the New York City Center for Family Representation and resulted in shorter lengths of stay in foster care compared to the outcomes for cases that were not served by the program.

Dependency Court Performance Measures (Rule 5.505)

The legislation that created the California Child Welfare Council also directed the Judicial Council to adopt performance measures by rule of court to complement the federal Child and Family Services Review measures required for child welfare agencies. Those court performance measures are found in California Rule of Court 5.505 and can serve as a model for the outcomes that high-quality legal representation should seek to accomplish.
