**Reason for Increase:** The cost increase is based on the current bid of the first phase. The second phase will be funded later. ARF Fund savings to cover for the project cost increase.

Notes: FM Program budget share is 69.99%, therefore cost increase to FM Budget is \$438,673.


**Reason for Increase:** Cost increase is due to the identification of (4) additional planter boxes that were leaking and were not originally identified. The planters have a defective waterproof membrane and all 15,000 square feet of the membrane will need to be replaced.

Notes: FM Program budget share is 69.99%, therefore cost increase to FM Budget is \$56,433.

**Interior Finishes:** As part of the accessibility lawsuit settlement, ADA accessibility remediation remodel in restrooms on the 2<sup>nd</sup> and 3<sup>rd</sup> floors and witness seating area, install exterior ADA ramps and sidewalks, widen paths of travel in courtrooms, install automatic door operators and walk off carpet to entrance, install accessible tables in café and information counter, and install ADA signage.

**Electrical:** Correct failed Uninterruptible Power Supply (UPS) for IT server room, replace capacitors, fans and batteries – Lightning strike caused power surge that short circuited and crippled the UPS.
