Judicial Branch Administration: Presentation of Two Independent Reviews/Reports Regarding the California Court Case Management System (CCMS) (No Action Required)

This will be a presentation of the two independent reviews of CCMS to the Judicial Council, as well as a high level contextual overview of these reports. The first report is the Independent CCMS Code Quality Review, which is a quality assessment of the code used to develop the software behind CCMS.
