Item 1

Review of ITAC's rule proposal concerning electronic signatures.

Review the rule proposal created by ITAC's Rule and Policy subcommittee to comply with recently enacted legislation. Assembly Bill 976 requires that, when a

document to be filed requires a signature made under penalty of perjury, the document is considered signed by the person if: "The person has signed the document using a computer or other technology pursuant to the procedure set forth in a rule of court adopted by the Judicial Council by January 1, 2019." The council is required to adopt a rule by 2019 prescribing the procedure for filers to sign documents filed electronically with the courts.

The ITAC's Rule and Policy subcommittee has developed a proposed rule, on which the Records Management Subcommittee should provide comments.
