## Item 1

# Diversion programs update to California Penal Code 1000 (Action Required)

The presenter discussed how a court was seeking clarification on the correct mapping/ definition of diversion programs in JBSIS to discern whether the reporting standards should only refer to drug court-related diversion programs or if the JBSIS current standard should be revised to include other types of diversion programs that have been added since its creation. The committee voted to propose a recommendation to the Court Executives Advisory Committee to change Rule of Court 2.2(m)(2)(C) to include all types of diversion programs.

## Data collection plan for CARE Act, SB 929 (Action Required)

The presenter summarized two recent bills with possible impacts on JBSIS data reporting and proposed that the committee consider adding CARE Act cases to JBSIS 4.0 data reporting because that filing type adds a new workload to courts. The presenter recommended not adding Community Mental Health Data Reporting to JBSIS because the reporting requirements in this bill do not create a new filing type nor a new workload for trial courts. The committee voted unanimously to adopt the recommendation.
