# Firearm Relinquishment Grant Program Recommendations (Action Required)

After consideration and vote, the committee recommended that the Judicial Council approve the allocation and distribution of \$1,551,777 to Orange Superior Court to fund a new Firearm Relinquishment program for Fiscal Years 2023–2025. Staff noted that the other applicant, San Francisco Superior Court,

withdrew their request for funding. The committee also recommended that the Judicial Council delegate authority to the Family and Juvenile Law Advisory Committee to distribute and reallocate any unspent funding from the grant awards to any of the awarded courts, based on the same criteria established during the application period.

Motion to approve by Ms. Mary Davis and seconded by Judge B. Scott Thomson. The motion carried. Judge Craig Arthur abstained from voting.
