Discretionary Tribal Participation Rules and Forms Proposal

Presenter: Ann Gilmour, Attorney, Center for Families, Children & the Courts, Judicial Council of California

Ann Gilmour provided the committee with an update on the Discretionary Tribal Participation Rules and Form Proposal. The comment period has ended. Commenters generally agreed with the proposal but suggested changing the placement within the rules to reflect that it will only apply to juvenile cases and

not to family law, and probate guardianship cases. Proposed changes to the rule and form do not substantially change the language and are highlighted in yellow in the materials. The committee decided to endorse the proposal with agreed edits to the rule and form on the condition of the result of the impending Brackeen case decision.

Item 3

Tribal Diversion Memorandum of Understanding between the Yurok Tribe, the Humboldt County Superior Court, and the Humboldt County District Attorney's Office

Presenters: Hon. Abby Abinanti, Chief Judge of the Yurok Tribal Court, Hon. Joyce Hinrichs, Judge of the Superior Court of California, County of Humboldt

The co-chairs briefed the committee on the Tribal Diversion Memorandum of Understanding between the Yurok Tribe, the Humboldt County Superior Court, and the Humboldt County District Attorney's Office. With the memorandum in place, ideally this model can be replicated throughout the state with a level of statutory authority. This program is evolving and growing to provide support to more Yurok families and not just Yurok members.
