2. CLASSIFICATION AND COMPENSATION STUDY

The committee reviewed the June 28, 2013, authorization to E&P from the Judicial Council that E&P may act on behalf of the council to review and approve the selection of an outside entity for the organization-wide evaluation of the AOC's classification structure and compensation plan. That council decision was made with knowledge of the amounts of the four bids, without identification of the bidders, to 2013 Classification and Compensation Study, RFP Number HRSO-04-13-SS. On June 28, 2013, the council directed the Administrative Office of the Courts (AOC) to finalize the Request for Proposal (RFP) process and use an outside entity to conduct an organization-wide evaluation of the AOC's classification structure and compensation plan.

The committee also reviewed the methodology, criteria, and process used to score the bids. Finally, the committee reviewed the final bid scoring and findings.

The committee considered and approved, with no abstentions or votes in opposition, the awarding of the contract to the highest-scored bidder.

On September 13 and 16, 2013, the chair of the Executive and Planning Committee spoke with the four committee members who had been unable to attend the meeting on September 9. He conveyed the committee members' September 9 discussion, deliberation, and decision. One abstained from indicating a vote due to being out of the country and missing the September 9 meeting. The other three members who had been absent on September 9 indicated that they concurred with the committee's decision.

Action: The committee determined, on behalf of the Judicial Council as authorized on June 28, 2013, that the classification and compensation contract should be awarded to the highest-scored bidder, approved the selection of the highest scored bidder to conduct an organization-wide evaluation of the AOC's classification structure and compensation plan, and directed AOC staff to proceed with contract negotiations with the highest bidder.

ACTION ON PENDING LEGISLATION

a) AB 604 (Ammiano), as amended July 2, 2013 – Eyewitness identification
Requires, when law enforcement has adopted procedures for conducting photo and live lineups with eye witnesses, that courts give jury instructions about those procedures that are substantially similar to instructions set forth in the bill.

Requires the Judicial Council to develop a jury instruction on the electronic recording that is "substantially similar" to jury instruction language set forth in the bill.

Provides that upon the granting of the order, the court clerk shall allow no access to the court file and records. Requires the court to give the petitioner a copy of the order and inform the petitioner that he or she may state that the arrest never occurred. Clarifies that a court is only required to have a hearing on the petition if the prosecution so requests.

ACTION ON PENDING LEGISLATION

a) SB 569 (Lieu), as proposed to be amended – Interrogations: electronic recordation Requires, among other things, that a custodial interrogation of a minor 16 years or older who is suspected of committing a murder for which he or she may be tried as an adult be electronically recorded in its entirety, except as specified. The proposed amendments delete the requirement that the Judicial Council adopt a jury instruction on such custodial interrogations that is substantially similar to the lengthy and detailed language in the bill. Instead the proposed amendments require that a court, if such a custodial interrogation is not recorded, provide the jury with an instruction to be developed by the Judicial Council

that advises the jury to view the statements made in that custodial interrogation with caution.

Action: Oppose the provision requiring that a court, if a custodial interrogation of a minor accused of murder is not recorded, to provide the jury with an instruction to be developed by the Judicial Council. Take no position on the remaining provisions of the bill.

b) Trailer Bill Language – Creating a presumption of split sentencing

Creates a presumption for a split sentence for felony offenders sentenced to county jail. Dictates that unless the court finds it is not appropriate, in the interest of justice, the court must suspend execution of part of the term and order mandatory supervision for that portion of the term.

Action: Oppose unless amended to (a) provide adequate funding to counties for supervision services, including rehabilitative programs and risk/needs assessments and (b) clarify that courts may consider lack of sufficient resources as a factor in deciding whether deviating from the presumption for a specific period of mandatory supervision is appropriate in the interests of justice.

ACTION ON PENDING LEGISLATION

- a) AB 1127 (Chau), as amended September 6, 2013 Legal aid: court interpreters
 Allocates \$6 million from the Trial Court Trust fund for a pilot program publicly funding interpreters in civil cases in three counties.
 - Action: Neutral, but communicate to administration reason why we are not in support.
- b) SB 743 (Steinberg), as amended September 6, 2013 Environmental quality: judicial review streamlining for environmental leadership development projects and entertainment and sports center in the City of Sacramento

 Among other things, requires the Judicial Council, on or before July 1, 2014, to adopt a rule of court to establish procedures applicable to certain lawsuits seeking review of a public agency's action in certifying an environmental impact report and in granting project approvals for a downtown arena project in the City of Sacramento. Directs that the procedures established by the rule require that actions or proceedings, including any appeals therefrom, be resolved, to the extent feasible, within 270 days of the certification of the record of proceedings. Amends the recently-enacted expedited judicial review procedures in AB 900 (Stats. 2011, ch. 354) by requiring the council to adopt a parallel rule of court, under the same deadline, which applies the same 270-day timeline for the courts to resolve lawsuits challenging projects that have been certified pursuant to the AB 900 process. Limits the forms of injunctive relief that the court may use in any action challenging the downtown arena project, as specified.
