1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above ("Agreement"). As set forth in the Agreement, the term "Contractor" refers to **Netronix Integration, Inc.** and the term "Judicial Council" or "State" refers to the **Judicial Council of California**.
2. This Amendment becomes effective on: **November 1, 2019**.
3. The parties agree to amend the Master Agreement as follows:

- a) Revise Exhibit 6 1.4 Ordering Process and replaced with the following:


Contractor will establish a customer account with the Judicial Council for requesting services on behalf of any JBE under this Agreement and an individual account for any JBE that elects to request services directly from the Contractor.

- b) Revise Exhibit 6 1.10 Procurement Process – Use of Master Agreement and replaced with the following:

Requests for goods and services as specified in this Agreement will be made by the Judicial Council and JBEs through the issuance of a Scope of Work. The Scope of Work will reference the Agreement number and will list and describe all of the requested goods and services. The terms and conditions of the Agreement shall take precedence over the terms and conditions of any Scope of Work, contract or terms and conditions included on an invoice or like document unless changes are made by reference to specific provisions of this Agreement.

- c) All references to Work Order in this Agreement will be replaced with Scope of Work.

4. Except as provided in this Amendment, all terms and conditions of the Agreement, as previously amended, shall remain in full force and effect.
