Opinion filed: Order to show cause discharged

Because our order to show cause and reference order were limited to the claim of ineffective assistance of counsel at the penalty phase of petitioner's capital trial, we do not address any other claim raised in the petition for writ of habeas corpus. The remaining claims will be resolved by a separately filed order. (See *In re Boyette* (2013) 56 Cal.4th 866, 898.)

The order to show cause is discharged.
