Probation revoked

The court orders that the probation of FRANKLIN SAMUEL ADLER (Respondent), State Bar Number 56417, is revoked. The court further orders that Respondent is suspended from the practice of law for one year, execution of that period of suspension is stayed, and Respondent is placed on probation for one year subject to the following conditions:

1. Respondent is suspended from the practice of law for the first six months of probation.
2. Respondent must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order filed on February 7, 2019
3. At the expiration of the period of probation, if Respondent has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

Respondent must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Respondent must also maintain the records of compliance as required by the conditions of probation.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
