### NUNEZ ON DISCIPLINE

Probation revoked

The court orders that the probation of RENE CHAVEZ NUNEZ, State Bar Number 226171, is revoked. The court further orders that:

- 1. RENE CHAVEZ NUNEZ is suspended from the practice of law for a minimum of one year, and he will remain suspended until the following requirements are satisfied:
  - i. He makes restitution to Juan Carlos Frigerio in the amount of \$748 plus 10 percent interest per year from September13, 2012 (or reimburses the Client Security Fund, to the extent of any payment from the fund to Juan Carlos Frigerio, in accordance with Business and Professions Code section 6140.5) and furnishes proof to the State Bar's Office of Probation in Los Angeles; and
  - ii. If RENE CHAVEZ NUNEZ remains suspended for two years or more as a result of not satisfying the preceding condition, he must also provide proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.2(c)(1).)

2.RENE CHAVEZ NUNEZ is given credit towards the one-year suspension for the period of involuntary inactive enrollment which commenced on February 2, 2014.

RENE CHAVEZ NUNEZ must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
