S211299**FRENCH ON DISCIPLINE**

Probation revoked

The court orders that the probation of ROBERT MARSHALL FRENCH, State Bar Number 98654, is revoked. The court further orders that:

1. ROBERT MARSHALL FRENCH is suspended from the practice of law for a minimum of one year, and he will remain suspended until the following conditions are satisfied:
 - i. He makes restitution to Reuben, Raucher & Blum in the amount of \$7,000 and furnishes proof of such restitution to the State Bar's Office of Probation in Los Angeles; and
 - ii. If he remains suspended for two years or more as a result of not satisfying the preceding condition, he must also provide proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law before his suspension will be terminated. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.2(c)(1).)
2. ROBERT MARSHALL FRENCH is given credit towards the suspension for the period of involuntary inactive enrollment which commenced on February 6, 2015.

ROBERT MARSHALL FRENCH must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
