Extension of time granted

Based upon counsel Jonathan P. Milberg's representation that the appellant's reply brief is anticipated to be filed by December 11, 2019, an extension of time in which to serve and file that brief is granted to October 15, 2019. After that date, only one further extension totaling about 62 additional days is contemplated.

An application to file an overlength brief must be served and filed no later than 60 days before the anticipated filing date. (See Cal. Rules of Court, rule 8.631(d)(1)(A)(ii) & (B)(ii).)
