Probation revoked

The court orders that the probation of DOUGLAS ROBERT SHOEMAKER, State Bar Number 230379, is revoked. The court further orders that DOUGLAS ROBERT SHOEMAKER is suspended from the practice of law for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

1. DOUGLAS ROBERT SHOEMAKER is suspended from the practice of law for the first six months of his probation.
