Order: (dispositive)

The Motion for Admonition and Extension of Time filed January 7, 2015, is denied.

The court orders that MARLON HOLDEN BATEMAN, State Bar Number 50080, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

1. MARLON HOLDEN BATEMAN is suspended from the practice of law for the first 30 days of probation;
2. MARLON HOLDEN BATEMAN must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on October 10, 2014; and
3. At the expiration of the period of probation, if MARLON HOLDEN BATEMAN has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

MARLON HOLDEN BATEMAN must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).) Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. One-third of the costs must be paid with his membership fees for each of the years 2016, 2017, and 2018. If MARLON HOLDEN BATEMAN fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.
