The Supreme Court of California convened in the Ronald M. George State Office Complex, Milton Marks Auditorium, Lower Level, 350 McAllister Street, Fourth Floor, San Francisco, California, on Tuesday, January 5, 2016, at 9:00 a.m.

Present: Chief Justice Tani Cantil-Sakauye, presiding, and Associate Justices Werdegar, Chin, Corrigan, Liu, Cuéllar, and Kruger. During the proceedings, Associate Justice Werdegar was suddenly indisposed and had temporarily left the bench. The Chief Justice announced that Justice Werdegar would listen to the tapes of any portions of oral argument that occurred in her absence. Thereafter, Justice Werdegar returned to the bench and sat for the third case.
