Recommended discipline imposed: disbarred

The court orders that JAMIE EDWARDS QUADRA, State Bar Number 228956, is disbarred from the practice of law in California and that her name is stricken from the roll of attorneys. JAMIE EDWARDS QUADRA must make restitution to the following payees:

- (1) Ronald and Maria Chin in the amount of \$7,540 plus 10 percent interest per year from January 23, 2016;
- (2) Michael Noble in the amount of \$18,750 plus 10 percent interest per year from January 19, 2016; and
- (3) Michael Noble in the amount of \$2,000 plus 10 percent interest per year from December 1, 2015.

1. JOHN EOM must comply with the conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on September 21, 2017; and
2. At the expiration of the period of probation, if JOHN EOM has complied with the terms of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

Recommended discipline imposed: disbarred

The court orders that ROBERT GLENN V. CAMPBELL, State Bar Number 212149, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys.

ROBERT GLENN V. CAMPBELL must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

S245301**VALENCIA ON DISCIPLINE**

Recommended discipline imposed

The court orders that MARIO GILBERTO VALENCIA, State Bar Number 235749, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

1. MARIO GILBERTO VALENCIA is suspended from the practice of law for the first 30 days of probation;
2. MARIO GILBERTO VALENCIA must comply with the other conditions of probation

recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on September 14, 2017; and

3. At the expiration of the period of probation, if MARIO GILBERTO VALENCIA has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

MARIO GILBERTO VALENCIA must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

One-half of the costs must be paid with his membership fees for each of the years 2019 and 2020. If MARIO GILBERTO VALENCIA fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

DREW ALLAN CICCONI must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

S245304**RIVAS ON DISCIPLINE**

Recommended discipline imposed: disbarred

The court orders that STEVEN CHRISTOPHER RIVAS, State Bar Number 213649, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys.

STEVEN CHRISTOPHER RIVAS must make restitution to Paul and Joanna Rivas in the amount of \$25,962.13 plus 10 percent interest per year from November 13, 2013 (or reimburse the Client Security Fund, to the extent of any payment from the Client Security Fund to Paul and/or Joanna Rivas, in accordance with Business and Professions Code section 6140.5), as set forth in the restitution recommendation of the Hearing Department of the State Bar Court in its Decision filed on July 26, 2017. Any restitution owed to the Client Security Fund is enforceable as provided in Business and Professions Code section 6140.5, subdivisions (c) and (d).

STEVEN CHRISTOPHER RIVAS must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section

6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

S245298**HANSEN ON RESIGNATION**

Resignation accepted with disciplinary proceeding pending

The voluntary resignation with charges pending of KIMBERLY ALLYSON HANSEN, State Bar Number 167597, as a member of the State Bar of California is accepted. If KIMBERLY ALLYSON HANSEN subsequently seeks reinstatement, the State Bar may consider all disciplinary charges that are currently pending against her.

KIMBERLY ALLYSON HANSEN must also comply with rule 9.20 of the California Rules of Court and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may be considered in any future reinstatement proceeding.
