The order filed on November 20, 2013, suspending KENNETH JOHN KLEINBERG from the practice of law is hereby amended *nun pro tunc* to read in its entirety:

“The court orders that KENNETH JOHN KLEINBERG, State Bar Number 110732, is suspended from the practice of law in California for three years, execution of that period of suspension is stayed, and he is placed on probation for four years subject to the following conditions:

1. KENNETH JOHN KLEINBERG is suspended from the practice of law for the first months of probation (with credit given for inactive enrollment, which was effective August 15, 2011, through September 3, 2012 (Bus. & Prof. Code, § 6122);
2. KENNETH JOHN KLEINBERG must also comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Decision filed on July 22, 2013; and
3. At the expiration of the period of probation, if KENNETH JOHN KLEINBERG has complied with all conditions of probation, the three-year period of stayed suspension will be satisfied and that suspension will be terminated.

KENNETH JOHN KLEINBERG must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar’s Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).) Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. Costs must be paid with his membership fees for the year 2015.”
