CONGDON ON DISCIPLINE

Probation revoked

The court orders that the probation of BYRON EDWIN CONGDON, State Bar Number 123286, is revoked. The court further orders that:

- 1. BYRON EDWIN CONGDON is suspended from the practice of law for a minimum of two years, and he will remain suspended until the following requirement is satisfied:
 - i. He must provide proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law before his suspension will be terminated. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.4(c)(ii).)
 - 2. BYRON EDWIN CONGDON is given credit towards the two-year suspension for the period of involuntary inactive enrollment which commenced on October 27, 2013.

BYRON EDWIN CONGDON must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

Probation revoked

The court orders that the probation of LISA BOEGLER NEVAREZ, State Bar Number 206226, is revoked. The court further orders that LISA BOEGLER NEVAREZ is suspended from the practice of law for one year, execution of that period of suspension is stayed, and she is placed on probation for three years subject to the following conditions:

- 1. LISA BOEGLER NEVAREZ is suspended from the practice of law for the first year of her probation.
- 2. LISA BOEGLER NEVAREZ must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order filed on November 25, 2013.
- 3. At the expiration of the period of probation, if LISA BOEGLER NEVAREZ has complied with all conditions of probation, the one-year period of stayed suspension will be satisfied and that suspension will be terminated.
