Brown* (2017) 3 Cal.5th 808, 862, reh’g. den. Oct. 25, 2017.) Under section 1509, subdivision (g) of the Penal Code, the court exercises its authority to retain this petition and decide it.

All claims in the petition are denied on the merits.

Claim 2, except to the extent it alleges ineffective assistance of counsel, is procedurally barred under *In re Waltreus* (1965) 62 Cal.2d 218, 225, to the extent it was raised and rejected on appeal. Claims 1, 2, 3, and 7, except to the extent they allege ineffective assistance of counsel, are procedurally barred under *In re Dixon* (1953) 41 Cal.2d 756, 759, to the extent they could have been raised on appeal but were not.

Claim 14 is denied as premature, without prejudice to its renewal after an execution date is set. To the extent Claim 1 contends there was insufficient evidence at his trial to support petitioner's conviction, such a contention is not cognizable on habeas corpus. (*In re Lindley* (1947) 29 Cal.2d 709, 723.)
