Recommended discipline imposed: disbarred

The court orders that DAVID JAMES LOLA, State Bar Number 231190, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys.

DAVID JAMES LOLA must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

#### MA ON DISCIPLINE

Recommended discipline imposed: disbarred

The court orders that LAWRENCE TANG MA, State Bar Number 265868, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys.

## MACARAEG ON DISCIPLINE

Recommended discipline imposed: disbarred

The court orders that CHRISTOPHER RAMOS MACARAEG, State Bar Number 222120, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys.

CHRISTOPHER RAMOS MACARAEG must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

#### PIETRO ON DISCIPLINE

Recommended discipline imposed: disbarred

The court orders that GINO PAUL PIETRO, State Bar Number 129582, is summarily disbarred from the practice of law and that his name is stricken from the roll of attorneys.

GINO PAUL PIETRO must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

#### **NUNEZ ON DISCIPLINE**

Recommended discipline imposed

The court orders that RENE CHAVEZ NUNEZ, State Bar Number 226171, is suspended from the practice of law in California for three years, execution of that period of suspension is stayed, and he is placed on probation for three years subject to the following conditions:

- 1. RENE CHAVEZ NUNEZ is suspended from the practice of law for a minimum of the first two years of probation, and he will remain suspended until he provides proof to the State Bar Court of his rehabilitation, fitness to practice and present learning and ability in the general law. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.2(c)(1).)
- 2. RENE CHAVEZ NUNEZ must also comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Decision filed on March 1, 2016.
- 3. At the expiration of the period of probation, if RENE CHAVEZ NUNEZ has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

RENE CHAVEZ NUNEZ must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

### **QUINN ON DISCIPLINE**

Recommended discipline imposed: disbarred

The court orders that ANDREW WILLIAM QUINN, State Bar Number 209654, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys. ANDREW WILLIAM QUINN must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

### TAYLOR ON DISCIPLINE

Recommended discipline imposed

The court orders that KEVIN RENARD TAYLOR, State Bar Number 218711, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for two years subject to the following conditions:

- 1. KEVIN RENARD TAYLOR is suspended from the practice of law for the first 60 days of probation;
- 2. KEVIN RENARD TAYLOR must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on March 17, 2016; and
- 3. At the expiration of the period of probation, if KEVIN RENARD TAYLOR has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. One-third of the costs must be paid with his membership fees for each of the years 2017, 2018, and 2019 . If KEVIN RENARD TAYLOR fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.
