S247852 **ANGULO ON DISCIPLINE**
Recommended discipline imposed: disbarred

The court orders that GEORGE RAFAEL ANGULO, State Bar Number 195700, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys. GEORGE RAFAEL ANGULO must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

S248243 **ESHRAGHI ON DISCIPLINE**
Recommended discipline imposed

The court orders that KHASHAYAR ESHRAGHI, State Bar Number 229557, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

1. KHASHAYAR ESHRAGHI must comply with the conditions of probation recommended by

the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on March 2, 2018; and

2. At the expiration of the period of probation, if KHASHAYAR ESHRAGHI has complied with the terms of probation, the one-year period of stayed suspension will be satisfied and that suspension will be terminated.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. One-third of the costs must be paid with his membership fees for each of the years 2019, 2020, and 2021. If KHASHAYAR ESHRAGHI fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

S248268**NAKAWAKI ON DISCIPLINE**

Recommended discipline imposed

The court orders that GLENN KAZUO NAKAWAKI, State Bar Number 118064, is suspended from the practice of law in California for two years, execution of that period of suspension is stayed, and he is placed on probation for three years subject to the following conditions:

1. GLENN KAZUO NAKAWAKI is suspended from the practice of law for the first year of probation;
2. GLENN KAZUO NAKAWAKI must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on March 6, 2018; and
3. At the expiration of the period of probation, if GLENN KAZUO NAKAWAKI has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

GLENN KAZUO NAKAWAKI must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
