Recommended discipline imposed: disbarred

The court orders that ESTRELITA LANE, State Bar Number 215086, is disbarred from the practice of law in California and that her name is stricken from the roll of attorneys.

ESTRELITA LANE must make restitution to Mark Halper in the amount of \$2,000.00, plus 10 percent interest per year from February 23, 2012. Any restitution owed to the Client Security Fund is enforceable as provided in Business and Professions Code section 6140.5, subdivisions (c) and (d).

Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

THEODORE SHIN LEE must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

**S217317****PECEL ON DISCIPLINE**

Recommended discipline imposed: disbarred

The court orders that ALEXANDER JOHN PECCEL, State Bar Number 167229, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys.

ALEXANDER JOHN PECCEL must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

Recommended discipline imposed

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
