Probation revoked

The court orders that the probation of JACK NEIL SWICKARD, State Bar Number 135429, is revoked. The court further orders that JACK NEIL SWICKARD is placed on probation until August 15, 2017, subject to the conditions of probation recommended by the Hearing Department of the State Bar Court in its Order filed on January 31, 2014.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

**S183845****KLUGMAN ON DISCIPLINE**

Probation revoked

The court orders that the probation of STEVEN MARK KLUGMAN, State Bar Number 53902, is revoked. The court further orders that STEVEN MARK KLUGMAN is placed on probation for three years subject to the following conditions:

1. STEVEN MARK KLUGMAN is suspended from the practice of law for the first 30 days of his probation.
2. STEVEN MARK KLUGMAN must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on April 4, 2014.

STEVEN MARK KLUGMAN must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

**S197097****MUNSON ON DISCIPLINE**

Probation revoked

The court orders that the probation of CRAIG EUGENE MUNSON, State Bar Number 143833, is revoked. The court further orders that CRAIG EUGENE MUNSON is suspended from the practice of law for one year, execution of that period of suspension is stayed, and he is placed on probation for two years subject to the following conditions:

1. CRAIG EUGENE MUNSON is suspended from the practice of law for the first six months of his probation (with credit given for the period of involuntary inactive enrollment which commenced on March 15, 2014).
2. CRAIG EUGENE MUNSON must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order filed on March 12, 2014, and the Order Amending Order filed on May 6, 2014; and
3. At the expiration of the period of probation, if CRAIG EUGENE MUNSON has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

CRAIG EUGENE MUNSON must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period.

Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

CRAIG EUGENE MUNSON must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
