Probation revoked

The court orders that the probation of SCOTT ANTHONY GALLAND, State Bar Number 211330, is revoked. The court further orders that:

1. SCOTT ANTHONY GALLAND is suspended from the practice of law for a minimum of two years, and he will remain suspended until the following conditions are satisfied:
 - i. SCOTT ANTHONY GALLAND makes restitution to the following payees (or reimburses the Client Security Fund, to the extent of any payment from the fund to the payees, in accordance with Business and Professions Code section 6140.5) and furnishes proof to the State Bar's Office of Probation in Los Angeles:

- (1) Vicki Lomax in the amount of \$2,200 plus 10 percent interest per year from July 11, 2011;
 - (2) Brett Voris in the amount of \$5,000 plus 10 percent interest per year from January 12, 2010; and
 - (3) Herbert Robinson in the amount of \$3,830 plus 10 percent interest per year from February 7, 2012; and
- ii. SCOTT ANTHONY GALLAND provides proof to the State Bar Court of rehabilitation, fitness to practice and learning and ability in the general law. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.2(c)(1).)
2. SCOTT ANTHONY GALLAND is given credit towards the suspension for the period of involuntary inactive enrollment which commenced on February 20, 2015.

SCOTT ANTHONY GALLAND must also take and pass the Multistate Professional Responsibility Examination during the period of his suspension and provide satisfactory proof of passage to the State Bar's Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

SCOTT ANTHONY GALLAND must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
