S165998**PEOPLE v. PLATA (NOEL
JESSE) & TRAN (RONALD
TRI)**

Extension of time granted

Good cause appearing, and based upon counsel Catherine White's representation that the appellant Ronald Tri Tran's opening brief is anticipated to be filed by June 1, 2016, counsel's request for an extension of time in which to file that brief is granted to November 24, 2015. After that date, only three further extensions totaling about 189 additional days are contemplated. An application to file an overlength brief must be served and filed no later than 60 days before the anticipated filing date. (See Cal. Rules of Court, rule 8.631(d)(1)(A)(ii) & (B)(ii).)

Order filed

The order filed on September 9, 2015, signed by Cantil-Sakauye, C.J., is hereby amended to read in its entirety:

Petition for review denied. The court orders that DARRYL WAYNE GENIS, State Bar Number 93806, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for two years subject to the following conditions:

1. DARRYL WAYNE GENIS is suspended from the practice of law for the first 30 days of probation;
2. DARRYL WAYNE GENIS must comply with the other conditions of probation recommended by the Review Department of the State Bar Court in its Opinion filed on March 13, 2015; and
3. At the expiration of the period of probation, if DARRYL WAYNE GENIS has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

DARRYL WAYNE GENIS must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
