Probation revoked

The court orders that the probation of SWAZI ELKANZI TAYLOR, State Bar Number 237093, is revoked. The court further orders that:

1. SWAZI ELKANZI TAYLOR is suspended from the practice of law for a minimum of two years, and he will remain suspended until:
 - i. He makes restitution to the following payees (or reimburses the Client Security Fund, to the extent of any payment from the Fund to the payees, in accordance with Business and Professions Code section 6140.5) and furnishes proof to the State Bar's Office of Probation in Los Angeles:
 - (1) Rosane Castro in the amount of \$2,500 plus 10 percent interest per year from November 23, 2009;
 - (2) Alan Sukin in the amount of \$3,600 plus 10 percent interest per year from September 30, 2010;
 - (3) James Croxton in the amount of \$1,300 plus 10 percent interest per year from April 22, 2010;
 - (4) Wesley Harris and Elisa Torres in the amount of \$3,750 plus 10 percent interest per year from May 24, 2010;
 - (5) Harshadrai Kapadia in the amount of \$1,400 plus 10 percent interest per year from April 4, 2010; and
 - (6) Rick Bonneville in the amount of \$1,800 plus 10 percent interest per year from April 20, 2010.
 - ii. He provides proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std.1.2(c)(1).)
2. SWAZI ELKANZI TAYLOR is given credit towards the two-year suspension for the period of involuntary inactive enrollment which commenced on May 17, 2015.

SWAZI ELKANZI TAYLOR must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
