Order filed

Due to clerical error on the part of the State Bar of California. The order of this court filed July 13, 2017, is hereby modified to read in its entirety:

“The court orders that JOHN MICHAEL HARMATA, State Bar Number 131668, is suspended from the practice of law in California for three years, execution of that period of suspension is stayed, and he is placed on probation for three years’ subject to the following conditions:

1. JOHN MICHAEL HARMATA is suspended from the practice of law for a minimum of the first two years of probation and he will remain suspended until he provides proof to the State Bar Court of his rehabilitation, fitness to practice and present learning and ability in the general law. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.2(c)(1).)
2. JOHN MICHAEL HARMATA must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving

Stipulation filed on March 9, 2017, except for restitution. The condition of probation regarding restitution is set forth in numbered paragraph 3 of this order.

3. Respondent must make restitution to Glenda Rolle in the amount of \$1,200 plus 10 percent interest per year from July 30, 2015 (or reimburse the Client Security Fund, to the extent of any payment from the Fund to Glenda Rolle, in accordance with Business and Professions Code section 6140.5) and furnish satisfactory proof to the State Bar's Office of Probation in Los Angeles no later than 30 days after the effective date of this order; and
4. At the expiration of the period of probation, if JOHN MICHAEL HARMATA has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

JOHN MICHAEL HARMATA must also take and pass the Multistate Professional Responsibility Examination during the period of his suspension and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

JOHN MICHAEL HARMATA must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. One-third of the costs must be paid with his membership fees for each of the years 2018, 2019, and 2020. If JOHN MICHAEL HARMATA fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

All provisions of this order are entered nunc pro tunc to July 13, 2017, with the exception of restitution, which must be paid in accordance with the terms of this order."
