 - (7) Hal Bringman in the amount of \$5,400 plus 10% interest per year from January 13, 2012; and
- ii. If he remains suspended for two years or more as a result of not satisfying the preceding requirement, he must also provide proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law.
