2. BRIAN JOSEPH KUCSAN must also comply with the provision of the State Bar Act, the Rules of Professional Conduct, and all other conditions of probation recommended by the Hearing Department of the State Bar Court in its "Actual Suspension Order" approving the stipulation filed on March 27, 2014.
3. At the expiration of the period of probation, if BRIAN JOSEPH KUCSAN has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.
