- 1. Item #I-B: Due to limitations in our system, we are unable to report civil assessment collected and offsets in the four categories as requested on the report. The "Vision" System only captures the total civil assessment fee collected. It does not segregate the civil assessment collected and the cost of collections under each separate program such as Court Collections Program, Franchise Tax Board Collections, Department of Motor Vehicle Collections, and Third Party Collections.
- 2. Item #I-B-5: The combined total civil assessment includes 15% fee (\$202,557) charged by the Franchise Tax Board prior to remittance to the Court. This fee is based on the TOTAL revenue collected including base fine, penalty assessment, civil assessment, and other fees. We are unable to segregate the fees for civil assessment from the rest of the fees collected.
