**Guidelines for Release Recommendations**

Level 1: Own Recognizance unless violent felony w/weapon, sex offense, DUI w/priors or injury

Level 2: Pretrial Supervision

Level 3: Pretrial Supervision unless violent felony. If violent felony, detain

Level 4: Pretrial Supervision unless violent felony. If violent or serious felony, detain

Level 5: Pretrial Supervision unless violent felony. If violent or serious felony, detain

Level 6: Detain
